Proposed concept of the Emergency Department

Emergency Room Receives \$625,000 Grant

Susquehanna Health has received a \$625,000 grant from the **Williamsport-Lycoming Community Foundation**. This grant will help fund improvements to Emergency department services at The Williamsport Hospital & Medical Center as part of Project 2012, the health system's comprehensive \$250 million facility improvement plan.

The grant will be used to significantly expand and upgrade the hospital's current emergency facility, which presently serves approximately 55,000 patient visits a year, but was originally designed to accommodate only 35,000 patient visits a year. The increase in service capacity will benefit residents of Lycoming County by improving the speed and efficiency of patient flow, enhancing patient comfort and privacy, better accommodating family members, decreasing the overall length of stay and improving medical outcomes for all emergency patients. Presently, delays in service are unavoidable due to a lack of space that causes the Emergency department to become backed up very early in the day. Some of the specific benefits of the improvement project include:

- Doubling the existing square footage to create private treatment spaces to include urgent, trauma, crisis and observation rooms.
- Replacing curtained areas with examination rooms to give patients more privacy.

Steven P. Johnson, SH President & CEO says, “Few projects in our lifetime will have as much significance to as many people in the Williamsport area as the expansion and renovation of the Emergency department at The Williamsport Hospital & Medical Center. The expanded bed capacity and related services will allow residents in our community to receive the highest quality emergency care without leaving Lycoming County.

“With the generous support of the Williamsport-Lycoming Community Foundation, the new ED facility will enable us to provide the kind of timely service and high-quality, personalized care our patients and their families expect and deserve.”

Planned Giving – Bequest In A Will

A popular and easy way to make a planned charitable gift is to include a bequest in your Will. You designate a portion of your estate to be used for the benefit and support of the charitable organization of your choice. This bequest enables you to make a charitable contribution that may not have been possible to make during your lifetime. It does not make any change to your immediate financial situation as you retain the use and control of the assets during your lifetime.

A bequest in your Will can take many forms. It can be a specific amount of money, a specific asset, a percentage of your estate or the entire residual of your estate. Your gift can be an outright gift or a contingent gift based on the occurrence of a certain event.

In addition, your gift can be designated for the general support of the charitable organization or restricted to a specific purpose you feel is important. As with any charitable bequest, your estate receives a charitable deduction for inheritance tax and estate tax purposes for the full amount of the gift.

Your personal objectives and circumstances will determine the exact amount and form of your gift. You should consult with your attorney for advice regarding your particular situation.
